



The process is organized step by step in order to gather the agreement from the factories for the public communication and in order to build publicly the network of ICS members' subcontractors. The board mission of knit Concern Group is to private its customers the best possible satisfaction and value for their money facilitating them with one-stop knitwear sourcing services.


